First Questions:

1. From Councillor Alan Dowden to the Leader – to be responded to by Councillor Mel Kendal, Executive Member for Economic Development:

"Would the Leader of the County Council, Councillor Roy Perry, explain to Members why we allow Hampshire Catering Services (HC3S) to provide in Hampshire schools, packaging of some items that cannot be recycled such as tetrapaks and small plastic pots of fruit juice which require a plastic straw, and desserts in small rigid pots which are difficult to recycle instead of providing juice drinks in small screw top bottles and washable pots for desserts that can be re-used or other bio degradable containers?"

2. From Councillor Keith House to the Leader, Councillor Roy Perry:

"Does the Leader recognise the Prime Minister's pledge that austerity has ended?"
