- 4.149. 04 Dec. Patrol conducted mooring and pontoon checks. Routine liaison with the Crown Estate mooring contractor. Post sunset, stopped an inbound fishing vessel and directed to illuminate navigation lights.
- 4.150. 05 Dec. Patrol conducted mooring and pontoon checks. Further liaison with the Crown Estate mooring contractor. Patrol stopped and gave advice to a motor vessel creating excessive wash off Warsash.
- 4.151. 06 Dec. Patrol conducted mooring and pontoon checks. Routine liaison with Hampshire Marine Police Unit.
- 4.152. 07 Dec. Patrol conducted mooring and pontoon checks. Liaison with HM Coast Guard with regard to a failed light in Southampton Water. Patrol searched for a large piece of wood, reported afloat off Swanwick. Nothing found.
