## Addendum to Agenda Item 6 of the Meeting of the River Hamble Harbour Board on Friday 7 Jan 2022

- 12.123. 29 Nov. Yard maintenance work. Liaison with the Crown Estate mooring contractor.
- 12.124. 30 Nov. Routine maintenance of Aids to Navigation. Office Christmas roof decoration preparation.
- 12.125. 01 Dec. Liaison with the Crown Estate mooring contractor. Light traffic in building winds.
- 12.126. 02 Dec. Office Yard refuse facility construction work. Light traffic.
- 12.127. 03 Dec. Patrol craft ant-foul trial work. Completed construction of yard refuse platform. Light traffic.
- 12.128. 04 Dec. Re-location of a number of mid-stream moored vessels off Hamble Point prior to commencement of dredging operations. Support to Bird Aware Solent. Assistance given to a motor vessel fouled on a picking-up rope.
- 12.129. 05 Dec. Continuation of yacht re-location prior to dredging operations. Re-secured flogging headsail on a mid-stream moored yacht.
- 12.130. 06 Dec. Assistance given to a motor vessel fouled on a picking-up rope. Continuation of vessel re-location prior to dredging operations.
- 12.131. 07 Dec. Morning check of Hamble Jetty following a report of icing. Pumped out a yacht sitting lower in the water than usual. No obvious source of ingress. Liaison with owner. Re-secured a loose mainsail halyard on a mid-stream moored yacht. Re-furled a loose headsail on a second mid-stream moored yacht.
- 12.132. 08 Dec. Clearance of footpath, yard and slipway following surge tides, reaching 5.4m (4.7m predicted). Pumped out cockpit of a mid-stream moored yacht with blocked scuppers. Refitted a loose dodger to a midstream moored yacht. Assistance given to a boat owner trapped in a lazarette locker. Boat owner unable to free the hatch but had his mobile telephone on hand. Liaison with the Crown Estate mooring contractor.
- 12.133. 09 Dec. Assembly and installation of the RHHA annual Christmas roof decoration. Slipway clearance work at Warsash. Flotsam collected and placed in yard for disposal.
- 12.134. 10 Dec. Routine patrol boat maintenance. Liaison with the Crown Estate mooring contractor regarding forthcoming pile maintenance programme. Liaison with the Environment Agency and Southern Water to resolve drainage issue in lower Warsash.
- 12.135. 11 Dec. Liaison with Hampshire Constabulary regarding an incident in Shore Road car park. Adjustment of vessels on the mid-stream Visitors' Pontoon.

- 12.136. 12 Dec. Liaison with the Crown Estate mooring contractor regarding the replacement of a failed pile iron. Further liaison with the Environment Agency and Southern Water (on site) to resolve local drainage issues. Preparations for annual commercial billing. Liaison with owners displaced from the 'A' run by dredging operations.
- 12.137. 13 Dec. Liaison with a visiting RNLI vessel. Preparations for annual commercial billing round. Light traffic.
- 12.138. 14 Dec. Liaison with Hampshire Marine Police Unit. Support to RNLI vessels conducting compass checks in the mouth of the River. Further liaison with EA and SW regarding drainage.
- 12.139. 15 Dec. Attended a vessel with persons unexpectedly on board to confirm bona fides. Vessel sold as part of a deceased former mooring holder's estate and those on board were grateful for the check. Day into night light audit.
- 12.140. 16 Dec. Patrol to the Horse and Jockey. Curbridge jetty remains in place pending Parish Council removal. Responded to reports from members of the public reporting two PWC speeding adjacent to Swanwick slipway. On arrival, neither vessel was located.
- 12.141. 17 Dec. Jetty maintenance at the River Hamble Country Park. Responded to a call from a member of the public reporting an apparently abandoned tender on the foreshore near the Chinese Bridge. Tender located but height of tide not conducive to recovery. Awaiting next higher tide.
- 12.142. 18 Dec. Light traffic. Tender at 12.141 recovered to Warsash.
- 12.143. 19 Dec. Support to dinghy racing activity at Warsash and Bursledon.
- 12.144. 20 Dec. Patrol to Botley channel. Nothing significant to report. Assistance given to a mooring holder whose propellor had become fouled on an adjacent mooring line.
- 12.145. 21 Dec. Liaison with 'Sea Start' to recover a yacht with a leaking diesel fuel pipe to Warsash for defect rectification. Liaison with dredging contractors over the positioning of an adjacent yacht. Resolved.
- 12.146. 22 Dec. Towed a yacht from her berth on the 'A' run to an alternative mooring to accommodate dredging operations.
- 12.147. 23 Dec. Liaison between a local fisherman and Hampshire Police regarding the theft of a tender. Later found abandoned at a sailing club.
- 12.148. 24 Dec. Light traffic.
- 12.149. 25 Dec. Office closed.
- 12.150. 26 Dec. Support to dinghy racing at Bursledon. Very few movements otherwise.

- 12.151. 27 Dec. Pre-pile replacement vessel survey. Light traffic.
- 12.152. 28 Dec. Check of vessels displaced by dredging operations.
- 12.153. 29 Dec. Routine liaison with Hampshire Marine Police Unit. Very light traffic in strong winds.
- 12.154. 30 Dec. Pumped out the flooded cockpit of a mid-stream moored yacht. Scuppers cleared. Replaced chafed line on point of failing on a mid-stream moored yacht. Owner informed.
- 12.155. 31 Dec. Checks on vessels at 12.154. Specific moorings check for the Mooring Officer.
- 12.156. 01 Jan. Support to Bird Aware for bird survey. Assistance given to a commercial vessel in coming alongside Hamble Jetty in strong winds. Assistance given to a resident motor vessel reporting a loss of power. Assisted onto her proper mooring.
- 12.157. 02 Jan. Specific mooring check for the Mooring Officer. Strong winds. Light traffic.
- 12.158. 03 Jan. Liaison with Hamble Life Boat regarding a Solent casualty.
