- 2.1. To seek adoption of the Moving Traffic Enforcement Policy which provides the policy framework and guiding principles for enforcing moving traffic offences in Hampshire.
- 2.2. Adoption of the Moving Traffic Enforcement Policy will support the County Council in its Network Management Duty under the Traffic Management Act 2004. This includes managing traffic and congestion and ensuring the expeditious movement of traffic on the road network.
- 2.3. Adoption of the policy will support the County Council's commitment to embedding a climate resilient integrated transport network that addresses the key challenges of congestion and environmental pollution in furtherance of a range of important outcomes as set out in national and local policy background, including:
 - managing the traffic network to ensure expeditious movement of traffic and reducing congestion;
 - improving road safety or promoting modal shift;
 - improving the quality and accessibility of public transport;

- improving the local environment, especially carbon reduction; and
- creating more pleasant places to live and work.

2. Reason(s) for the decision:

2.1. The purpose of this report is to agree the Andover Road Corridor Strategy and the County Council's approach to seeking improvements to the Cart and Horses Junction. A report is needed now in order that the County Council is well placed to input into the evolving local plan and to plans by National Highways to change Junction 9 of the M3. The report clarifies the County Council's position in relation to the Andover Road corridor, and if approved its recommendations will assist in responding to recent public representations.

3. Other options considered and rejected:

3.1. The option not to seek agreement to a corridor strategy was considered but in light of the need to provide clear advice as part of the local plan making process and to respond to the public requests for action this was rejected.

3.2.	The option to keep Andover Road open to all through traffic was considered

	by the Secretary of State to permit the Barton Farm (Kings Barton)
	development and close Andover Road to through traffic.

1. The decision:

1.1 That the Leader and Executive Member for Hampshire 2050 and Corporate Services approves the revised scheme priorities for Fleet as set out in paragraph 20 of the supporting report.

2. Reasons for the decision:

- 2.1. At a previous decision day held on 24 April 2018 the scheme priorities for Fleet were agreed. The priority reflected the funding climate and opportunities of the time and included the Fleet Station Junction scheme as the top priority. The funding climate has changed significantly with the Government Focus on levelling up meaning Fleet does not rate highly for funding as it is not in a priority area for levelling up.
- 2.2. There are a number of developer contributions held in Fleet and the surrounding areas. Some of the contributions held are time limited and they need to be allocated and spent on schemes that can be delivered before the funding expires. This means that the prioritisation of schemes in Fleet needs to be adjusted to reflect the practicalities of what is deliverable within the funding held and the terms of the funding agreements.

3.1. The option to continue with the priorities previously agreed was considered. However, continuing with this approach would risk locally held Section 106 developer contributions expiring before they can be used.

- 2.1. The Government has published guidance that requires Local Transport Authorities across the country to prepare Local Cycling and Walking Infrastructure Plans (LCWIPs) for their areas. Future funding for active travel is conditional upon such plans being developed and adopted. This report seeks to approve the LCWIP for Rushmoor Borough, following the approval of the LCWIP's for the south of Hampshire at a Decision Day on the 7th November 2022.
- 2.2. The Rushmoor LCWIP includes walking and cycling routes which have been prioritised following extensive engagement and consultation with local stakeholders and the community. The prioritised routes and associated proposed improvement schemes will help guide funding bids prepared by the County Council and Borough Council.

- 3.1. The option of not preparing the Rushmoor LCWIP would mean the County Council would be unlikely to secure future funding for active travel initiatives from Government funding sources.

would result in an LCWIP document that would not be compliant with Government guidance. The proposals within the LCWIP are of a higher standard due to the local knowledge that has informed the development of the document.

In particular the plans articulate at a local level what schemes the County Council and Local Planning Authorities should be seeking to secure through the development control process over time.
