Purpose of this Report

 The purpose of this report is to consider a grant request received from the New Forest Agricultural Show Society and to note an award recently made to the Friends of Hardway towards its D-Day event.

Recommendations

- 2. That a grant of £5,000 be awarded to the New Forest Agricultural Show Society towards the cost of the County Show being held during 30 July 1 August 2019. This grant to offset the costs of the County Council stands and purchasing tickets.
- 3. That the sum of £2,986 awarded to the Friends of Hardway by the Director of Transformation and Governance on 13 May 2019 towards its D-Day 75th Commemoration Event being held on 6 June 2019 be noted.

Executive Summary

- 4. This report is to consider a request received from the New Forest Agricultural Show Society for financial assistance towards the New Forest and Hampshire County Show. Details of this request is outlined in Appendix 2 to this report.
- 5. In addition to this, following the last Decision Day in April, a request was received from the Friends of Hardway seeking a grant towards its D-Day 75th Commemoration event being held on 6 June 2019.

- 6. Unfortunately, the next scheduled Decision Day where this request could be considered did not take place until after this event. In view of the timings, on 13 May 2019 the Director of Transformation and Governance agreed to award a grant of £2,986 towards this D-Day event. This decision is included in this report for the Executive Member to note.
- 7. The grants budget available at the meeting on 20 June 2019 is £144,014. This takes into account the grant detailed in paragraph 6 above.

Grants Criteria

8. A copy of the criteria used for considering grants from the Policy and Resources grants budget is attached as Appendix 1 to this report.

FUNDING CRITERIA FOR THE POLICY AND RESOURCES GRANTS

The following criteria should be taken into consideration when preparing a submission for funding. They are intended as guidelines and not prescriptive rules

- 1. Assistance will be considered only in response to direct applications from properly constituted organisations seeking assistance. You must show in your application that your organisation is properly and legally organised and has its own bank account.
- 2. Where appropriate, applications will be referred to the relevant service department (e.g. Adult Services, Culture, Communities and Business Services, Children's Services, etc.) for consideration.
- 3. Preference will be given to applications for specific projects or activities rather than general running costs of organisations. These grants are not intended to replace shortfalls in service delivery budgets or replace funding for other support you may be able to obtain, or that you have obtained from us in the past.
- 4. Grants will not usually be made in respect of applications from the following:-
 - District or Parish Councils
 - Government Institutions
 - Schools
 - Overseas and out of County organisations which have no direct Hampshire involvement
 - Branches or organisations assisted centrally with a sum from the County Council
 - Bodies requesting funds for onward distribution to other charities e.g. mayoral appeals, carnivals, fetes, or for their own fundraising events.
- 5. Applications will not be accepted from political parties or groups affiliated with a political party or from lobbying/campaigning organisations.
- 6. Applications will only be considered from faith groups who can demonstrate their facilities are open and used by the local community other than for church related activities and are for small one-off projects.
- 7. Requests may be considered from County wide groups (e.g. Guides, Scouts, Hampshire County Youth Orchestra) for specific trips, e.g. for an international jamboree or cultural tour. Individual requests will not usually be considered.
- 8. Where possible self-help within organisations should be encouraged and to this end, grants are normally a percentage of the sum required to complete the project.
- 9. As a general rule, grants in excess of £5,000 will not be awarded.
- 10. In general grants will only be awarded to projects which are taking place in the same year as application for funds.

The New Forest Agricultural Show Society is seeking grant aid of £5,000 towards the cost of running "The Heart of the Forest" area at the New Forest and Hampshire County Show being held between 30 July and 1 August 2019.

"The Heart of the Forest" is a hive of industry where visitors can learn about the people who work behind the scenes to make the New Forest thrive. Various organisations such as the New Forest Agisters, the New Forest National Park Authority and many more will educate visitors on the vast history of the New Forest and the way it is today.

A brand new Activity Zone will also be providing a variety of workshops and activities for visitors to take part in and enjoy.

Total cost: £15,160 (cost of "Heart of the Forest" area only)

Purpose of this Report

1. The purpose of this report is to identify the use of a procurement procedure, identified within The Public Contracts Regulations 2015 for Hampshire County Council's Memberships, Bookings and Electronic Point of Sale system (EPOS). The procedure identified is regulation 32, the negotiated procedure without prior publication that requires Executive Member approval in line with Contract Standing Orders (CSO) where the procurement has a value over £1 Million.

2. Recommendation

2.1. That the Executive Member for Policy and Resource approve this report and confidential appendix, in the use of regulation 32, the negotiated procedure without prior publication for Memberships, Bookings and Electronic Point of Sale system (EPOS).

Executive Summary

- 3. This report presents the following procurement in accordance with the County Council's Contract Standing Orders and Constitution.
- 3.1. The County Council's Contract Standing Orders (CSO) requires that the procurement of a Contract (not including a Framework Agreement) is subject to the approval of the relevant decision maker who has the authority to give approval for the relevant expenditure under the Constitution.

3.2. Due to the value of the call off Contract identified in this report, Hampshire County Council's Contract Standing orders require an approval for the use of the regulation 32, procurement process, where the estimated value of the contract is £1 Million or greater then approval of the Executive Member shall be sought for the use of the negotiated procedure without prior publication.

Contextual information

4. Memberships, Bookings and Electronic Point of Sale

Culture, Communities and Business Services (CCBS) require a software solution for membership, bookings and electronic point of sale (EPOS) system from May 2019.

Approval to spend was given on the 25th April at the Executive Member Decision Day.

The project went out to open tender under the Public Contract Regulation 2015, but unfortunately failed to receive any suitable tenders as all of the bidders requested different small amendments to be made which were not allowable at that time. A decision was made to explore the use of Regulation 32 of the Public Contract Regulation (Negotiation without Prior Publication) in order to meet the requirements of the service and negotiate with the supply market in order to identify the most suitable supplier to meet the services requirements.

Background and further legal context has been provided for this procurement in the Confidential Appendix.

Memberships/Loyalty/Booking & Tills (or Electronic Point of Sale devices) is delivered in varying ways across Outdoor Centres, Country Parks and Sir Harold Hillier Gardens and the catering outlets at these sites. There is a combination of electronic and manual booking, loyalty and membership processes at each site. The till functionality is also a mixture of manual (cash box) and basic electronic tills which do not communicate with the loyalty, membership and bookings systems. There are The Sir Harold Hillier Gardens, 3 outdoor centres, 8 Countryside sites and catering outlets at 7 sites which are in-scope of this project, with a view to expand to other Hampshire County Council services.
