## **14. THE REVISION OF LIVING DIFFERENCE**

The Agreed Syllabus Conference considered the report of the Director of Children's Services (Item 6 in the Minute Book) which summarised the background to the Agreed Syllabus review and recommended amendments for approval in order to produce a revised syllabus to distribute to schools in December 2016.

Members were given a brief synopsis of the work done towards this revision where the aim had been to amend and develop the current Agreed Syllabus, Living Difference revised 2011 in the light of current educational thinking, not to rewrite it. Pat Hannam and Justine Ball, the Inspectors for Religious Education, gave a powerpoint presentation (slides attached) which explained the similarities and changes.

It was emphasized that bringing more clarity to the process of enquiry and in its explanation and advice had been a key element in the review. Teachers had been fully involved, throughout the period of the review. It was highlighted that the revised syllabus now links with the language of other National Curriculum subjects, including the age-related expectations that must inform planning and progress. It was shown that Ofsted values the enquiry approach which is at the heart of the Hampshire syllabus. It was explained that the syllabus would only be available as a download with free access to all.

The four key changes – the re-emphasis that enquiry begins from a child's experience, the recognition of the distinctions between Abrahamic and Dharmic religious traditions, the more straightforward planning of a sequence of enquiries into concepts, and the close link between the current age-related expectations for progress and the progression model recommended in Living Difference III – were detailed.

During discussion and questions it was stressed that there was no intention in the RE syllabus to persuade young people to adopt a religious belief or to change their beliefs. Members commented that they valued the way the syllabus respected the integrity of the pupil in the way it presented both

religious and non-religious views, providing pupils with a framework and skill set to be able to evaluate these. They felt that the concepts were valuable and meaningful whether a pupil comes from a religious or non-religious background or not. Attention was drawn to the final, 'evaluate' step in the cycle which made children consider why the 'concept' they have been studying is important for a particular religion and whether it could make a difference to their own life.

In answer to a question regarding the involvement of academy schools in the process, it was stated that it was difficult for teachers to get time off, but they had been kept informed, and the Dioceses had involved all their schools.

After group discussions a vote was taken and it was unanimously agreed to adopt the revised Agreed Syllabus.

The Vice-Chairman, on behalf of all the members of SACRE, gave thanks to all those who had put in a lot of hard work on the revisions to produce a well-written document, giving special mention to Pat Hannam and Justine Ball.

**RESOLVED:**

That the Agreed Syllabus Conference approved the revised Agreed Syllabus, Living Difference III and that it is launched on 8 December 2016 and made available to schools from this point.

### Purpose of this Report

The purpose of this report is to request the Agreed Syllabus Conference to agree to review Living Difference III.

### Recommendation(s)

1. That the Agreed Syllabus Conference approves the report and agrees to review Living Difference III.

### Executive Summary

2. It is a statutory requirement of every local authority to review and if necessary, revise its Agreed Syllabus every five years. Beginning the review process now is timely, giving a year to undertake a careful review, ensuring a revised syllabus is put before the Agreed Syllabus Conference for adoption in November 2021.

### Contextual information

3. Living Difference III was adopted by the Agreed Syllabus Conference for use in schools in November 2016. The review process will be undertaken in conjunction with the other authorities who share this syllabus: Portsmouth, Southampton and the Isle of Wight. Arrangements are being made to ensure the Agreed Syllabus Conferences of these authorities are also agreeing to review at the same time.
