#### 1. The decision:

1.1 To approve an award of £200,000 to *Winchester Excavations,* which will include a significant contribution to the digitisation of the publications, and on condition of match funding and the phasing of payment according to the spend.

## 2. Reason(s) for the decision:

- 2.1 Between 1962 and 1971 the *Winchester Excavations Committee* (WEC) carried out the largest programme of archaeological excavations and historical research ever undertaken in a British city with more than 2000 people digging on its sites. The centre of interest was the city itself; the urban phenomenon and how it waxed and waned over 2000 years from the Iron Age, through Roman, Anglo-Saxon and medieval times down to the emergence of the modern city in the Victorian period.
- 2.2 In recent years Winchester Excavations Committee has been undertaking a major fund-raising campaign with the twin aims of publishing the remaining volumes of work and bringing the outcomes of the analyses to a wider audience

#### 1. The decision:

1.1 To approve an award of £75,000 to Hampshire Cultural Trust towards 878 *AD: An Anglo-Saxon Experience* on condition of the written commitment of the Trust to provide the balance of funding required.

#### 2. Reason(s) for the decision:

- 2.1 In 2019, the Leader agreed to broaden the criteria for the Investing in Hampshire Fund to incorporate 'projects that will support economic development and business growth within Hampshire'.
- 2.2 In the context of the County Council's efforts to support economic recovery from the CovId19 pandemic, this proposal will contribute to that objective.
- 2.3 The project will bring Anglo-Saxon Winchester to life using digital recreations from *Assassin's Creed: Valhalla* to create an immersive city-wide experience and a learning programme linking literacy and gaming. The project will be delivered by HCT in collaboration with global video-gaming company Ubisoft and UK creative innovation studio Sugar Creative.
- 2.4 The project aims to inspire local pride in Winchester's significant role in Anglo-Saxon history and in Hampshire's position as a centre for digital innovation. It is expected that 70,000 Hampshire residents may benefit from visiting the new attraction.

2.5 More broadly, it is recognised that the regeneration and diversification of Hampshire's High Streets, particularly through the provision of cultural and creative activity, is an important component in the region's post-pandemic recovery. It is expected that this project will raise the profile of, and bring wider audiences to, Hampshire's cultural attractions. The attraction and promotional activities around it will drive footfall to the city centre, generate spend in nearby shops, cafes, and restaurants, and contribute to the economic regeneration of Winchester.
