Addendum to Agenda Item 7 of the Meeting of the River Hamble Harbour Board on Friday 13 July 2018

- 4.38. 09 May. Patrol conducted mooring and pontoon checks. Reminder given to an individual bait digger at Warsash about Harbour Bye Law 31. Tow of a yacht to the midstream Visitors' Pontoon pending refurbishment of mooring. Attendance at Hamble Jetty regarding anti-social behaviour. Responded to a call from a boatyard in the Upper River regarding anti-social behaviour - a group of people swimming across the River near the motorway bridge. On arrival, swimmers had dispersed.
- 4.39. 10 May. Patrol conducted mooring and pontoon checks. Patrol gave a verbal warning to 3 Jet-ski owners for creating excessive wash at Swanwick.

  Monitoring of bait digging opposite Universal Marina. Report to SIFCA.
- 4.40. 11 May. Patrol conducted mooring and pontoon checks. Commercial coding work. Observation of a visiting yacht with potential for Border Force interest.
- 4.41. 12 May. Patrol conducted mooring and pontoon checks. Jet wash of Warsash Jetty. Recovered a racing mark for a dinghy sailing club.
- 4.42. 13 May. Patrol conducted mooring and pontoon checks. Towed a RIB with propulsion failure to a boatyard for repair. Responded to a 'pan' call reported via Solent Coastguard. Yacht adrift within the large vessel turning area off Cowes. Vessel assisted by Hamble Lifeboat. Monitored a subsequent 'Mayday' call from Solent Coastguard regarding a person reported in the water off Calshot. Person recovered by Calshot Lifeboat.
- 4.43. 14 May. Patrol conducted mooring and pontoon checks. Routine Marina liaison visit. Nothing significant to report.
- 4.44. 15 May. Patrol conducted mooring and pontoon checks. Patrol gave an official warning to a motor vessel found speeding in the Upper Hamble. Routine liaison with Crown Estate mooring contractors.
- 4.45. 16 May. Patrol conducted mooring and pontoon checks. Advice given to a mooring holder regarding theft relayed to the Police. Tow of 2 vessels from their proper moorings to the mid-stream Visitors' Pontoon on behalf of the Crown Estate.
- 4.46. 17 May. Patrol conducted mooring and pontoon checks. Assisted a tender alongside on the 'G' run. Contacted a RIB Charter company, based outside the Hamble regarding non-payment of fees. Hosted a routine visit from the Environment Agency.
- 4.47. 18 May. Patrol conducted mooring and pontoon checks. Commercial tow of a yacht to a boatyard for defect rectification. Liaison with a Marina reporting damage apparently caused by a visiting yacht.
- 4.48. 19 May. Patrol conducted mooring and pontoon checks. Supported the Hamble River Raid with two Patrol Craft. Nothing significant to report.

- 4.49. 20 May. Patrol conducted mooring and pontoon checks. Interview of potential seasonal Patrol Officers. Commercial coding work.
- 4.50. 21 May. Patrol conducted mooring and pontoon checks. Interview of potential seasonal Patrol Officers. Commercial coding work.
- 4.51. 22 May. Patrol conducted mooring and pontoon checks. Patrol responded to a report of a fuel spillage at a Boatyard in the Upper River. No evidence found. Patrol recovered an abandoned tender. Patrol returned a yacht to her proper mooring from the mid stream Visitors' Pontoon on behalf of the Crown Estate. Patrol liaised with a small group of Paddleboarders in the Main Channel off Warsash and advised on IRPCS.
- 4.52. 23 May. Patrol conducted mooring and pontoon checks. Liaison with Hampshire Police Marine Unit regarding a member of the public suffering a possible heart attack ashore at a Marina. Person recovered by air ambulance to Southampton General Hospital. Patrol responded to a further call from Hampshire Police Marine Unit regarding anti-social behaviour at Hamble Jetty. On arrival a group of youths were seen to be jumping into the water from Hamble Lifeboat. Youths dispersed.
- 4.53. 24 May. Patrol conducted mooring and pontoon checks. Commercial tow of a yacht from her mooring to a boatyard.
- 4.54. 25 May. Patrol conducted mooring and pontoon checks. Tide Gauge clean at Mercury and Bursledon. Liaison with Warsash History Society for whom the team had put together a visual display.
- 4.55. 26 May. Patrol conducted mooring and pontoon checks. Policing of RIB launches from Warsash Slipway. Liaison with Hampshire Police regarding further anti-social behaviour at Hamble Jetty. Offenders dispersed. Checked security of the sail on a mid stream moored yacht at the request of its owner. Assisted a tender, broken down with two persons on board off Port Hamble Marina.
- 4.56. 27 May. Patrol conducted mooring and pontoon checks. Patrol assisted a family in a small motorboat in fixing a leak. Escorted two weary Paddleboarders back to a Marina. Patrol towed a motor boat with propulsion failure back to her proper mooring. Patrol attended Hamble Jetty in response to a further report of anti-social behaviour. Offenders dispersed. Patrol towed a broken-down tender to Swanwick.
- 4.57. 28 May. Patrol conducted mooring and pontoon checks. Responded to a report from a passing motor boat that a yacht with two persons had become pinned against a moored craft in a strong ebb tide. On arrival, the yacht underway was obviously fast perpendicularly against the moored vessel in the strong ebb with some damage evident to both vessels. Vessel secured pending a reduction in the tidal stream and no casualties. Skipper of the yacht underway had misjudged the rate of the tide. Ownership details exchanged.

- 4.58. 29 May. Patrol conducted mooring and pontoon checks. Liaison with a mooring provider regarding the use of inappropriate ground tackle. Liaison with Hampshire Marine Police Unit and UK Border Force regarding a suspicious visiting yacht. Further liaison with owners of collision on 28 May.
- 4.59. 30 May. Patrol conducted mooring and pontoon checks. Monitoring and reporting to the proper authorities of extensive commercial bait digging at Crableck. Liaison with HMCG, Calshot Lifeboat and Hampshire Fire Service regarding a small yacht with a reported engine fire. There were no casualties and the fire had been extinguished. On that basis, it was deemed reasonably safe to be recovered to Warsash for defect rectification. Fire Service training held on HM Jetty. Patrol witnessed and reported to SIFCA a gang collecting cockles West of Hamble Spit at Low Water. Towed a yacht with propulsion failure to HM Jetty Warsash for defect rectification. Patrol recovered a large log from the Main Channel off Warsash.
- 4.60. 31 May. Patrol conducted mooring and pontoon checks. Routine pontoon maintenance at Warsash.
- 4.61. 01 Jun. Patrol conducted mooring and pontoon checks. Further routine pontoon maintenance at Warsash. Assisted a yacht in taking up a commercial tow from her proper mooring to Portsmouth for defect rectification.
- 4.62. 02 Jun. Patrol conducted mooring and pontoon checks. Liaison with a mooring holder whose mooring had been occupied illegally by a visiting boat. Patrol escorted a vessel under sail but without fuel to Port Hamble Fuel Jetty. Patrol towed a yacht with steering gear failure to the mid stream Visitors' Pontoon.
- 4.63. 03 Jun. Patrol conducted mooring and pontoon checks. Patrol attended Hamble Jetty in response to a report of further anti-social behaviour. Offenders dispersed. Liaison with Southampton HM Patrol regarding a broken down yacht. Yacht towed by Southampton Patrol to a yard for defect rectification. Further observation of cockle picking on Hamble Spit liaison with SIFCA. Vehicle registration number taken. Patrol took a report from a visiting yacht of a minor collision between her, departing her berth at Warsash and a sailing dinghy approaching her adjacent pontoon. No injuries and minor scuffing. Details exchanged and both warned about Bye Law 5, as well as IRPCS responsibilities.
- 4.64. 04 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with Hampshire Marine Police Unit. Commercial boat coding work.
- 4.65. 05 Jun. Patrol conducted mooring and pontoon checks. Patrol stopped and warned a RIB coxswain for speeding off the Warsash HM Jetty.
- 4.66. 06 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with Hampshire Marine Police Unit. Support to contractor wok to replace handrails on Hamble Jetty.

- 4.67. 07 Jun. Patrol conducted mooring and pontoon checks. Patrol responded to a report of a sheen of oil between 'H' and 'I' runs. On arrival, a small slick witnessed with no obvious source. Broken up with propellor wash. Routine liaison with a River marina.
- 4.68. 08 Jun. Patrol conducted mooring and pontoon checks. Advice about keeping a proper look-out given to a yacht departing a fuel berth.
- 4.69. 09 Jun. Patrol conducted mooring and pontoon checks. Tow of a vessel with propulsion failure for the mouth of the River to Hamble Point Marina for defect rectification.
- 4.70. 10 Jun. Patrol conducted mooring and pontoon checks. Patrol re-secured a loose pile line on a mid-stream moored yacht. Patrol towed a vessel with engine failure to her proper mooring for defect rectification. Routine liaison with a mid-stream mooring holder regarding pile maintenance.
- 4.71. 11 Jun. Patrol conducted mooring and pontoon checks. Routine pontoon maintenance work. Patrol dispersed swimmers from the Fishermens' Pontoon
- 4.72. 12 Jun. Patrol conducted mooring and pontoon checks. Patrol liaison with UK Border Force regarding two visiting yachts. Liaison with Southampton Harbour Master regarding the tracing of a yacht involved in a close quarters situation with a Red Jet ferry in Southampton Water. Liaison with HMCG to trace the owner of a fishing boat. Routine liaison with visiting MOD Police launch.
- 4.73. 13 Jun. Patrol conducted mooring and pontoon checks. Patrol responded to a telephone call from a member of the public reporting a number of males climbing onto the M27 bridge from a dory. Police contacted and Patrol attended. Dory matching the description located with all males embarked. Further liaison with Hampshire Police. On return to office, Patrol received a further report of the same boat in relation to anti-social activity at a Bursledon marina. Patrol attended the scene, gave a formal warning to the skipper of the dory and directed him to leave the River. Compliant.
- 4.74. 14 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with Southampton Harbourmaster regarding the location of a fishing vessel. Commercial tow of a vessel to the mid-stream Visitors' Pontoon.
- 4.75. 15 Jun. Patrol conducted mooring and pontoon checks. Final preparations for the Rive Hamble Games. Routine liaison with Hampshire Marine Police Unit. Patrol assisted parents in the recovery of their son's push-along scooter from the mud at Hamble Jetty. Call from a mid-stream mooring holder regarding his outboard motor, left by accident on his pontoon. Recovered.
- 4.76. 16 Jun. Patrol conducted mooring and pontoon checks. Support to River Hamble Games' safety. Over 300 competitors in swimming, sailing, kayaking, rowing and paddleboarding, as well as events ashore. Responded to a report of a berthing collision from a Marina made iaw Bye Law 9. Skipper error of

- judgement in moderate wind and cross-tide. Owners place in touch with one another.
- 4.77. 17 Jun. Patrol conducted mooring and pontoon checks. Patrol responded to a call from a canoeist in the Upper Hamble regarding a motor launch speeding and creating excessive wash. No name given for the offending motor launch, unlocated. Patrol recovered a large tree trunk from the River to the HM's yard at Warsash.
- 4.78. 18 Jun. Patrol conducted mooring and pontoon checks. Routine assistance rendered to mid-stream mooring holder in recovery of a sunken mooring line. Sign painting for the forthcoming charity Crabbing Competion.
- 4.79 19 Jun. Patrol conducted mooring and pontoon checks. Further preparation for the forthcoming crabbing competition. Routine patrol boat maintenance.
- 4.80. 20 Jun. Patrol conducted mooring and pontoon checks. Assisted a River sailing club in the location of a missing RIB. Boat coding work. Liaison with Hampshire Marine Police Unit to obtain sidescan sonar data in support of RIB location effort.
- 4.81. 21 Jun. Patrol conducted mooring and pontoon checks. Responded to call from a member of the public regarding a RIB speeding North in the mouth of the River. Vessel stopped and given a verbal warning. Attendance at Hamble Jetty to disperse swimmers.
- 4.82. 22 Jun. Patrol conducted mooring and pontoon checks. Support to 'ZapCat' motor boat event in Warsash. Attendance at RHCP Jetty to advise swimmers of the risks. Well received. Observation of bait digging at Crableck and liaison with Southern IFCA.
- 4.83. 23 Jun. Patrol conducted mooring and pontoon checks. Patrol witnessed a yacht aground off the 'M' Run in mud. Yacht refloated without assistance.
- 4.84. 24 Jun. Patrol conducted mooring and pontoon checks. Patrol responded to a call from HMCG out of hours regarding a black Audi car which had rolled into the River from the car park at Eastlands' Boatyard. No personnel were in the vehicle at the time. Liaison with the yard in question to address pollution issues and environmental compliance given yard's location in a SSSI. Appropriate authorities informed. Yard owner made aware in person of the need to recover the vehicle in a compliant manner.
- 4.85. 25 Jun. Patrol conducted mooring and pontoon checks. Patrol attendance at Hamble Jetty to disperse youths swimming in the vicinity and behaving in an anti-social manner (jumping from the bridge, climbing into private craft).
- 4.86. 26 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with the Crown Estate mooring contractor regarding forthcoming pile maintenance. Routine Patrol Craft maintenance. Further extended attendance at Hamble Jetty in an attempt to disperse swimmers and prevent anti-social behaviour. Youths swimming in front of approaching craft and climbing aboard the Pink

- Ferry. Police called and attended. Pontoon cleared. Patrol took a report of a further berthing collision at a mid-River marina. Detail of collision not witnessed although name of the offending vessel reported to patrol and search initiated. Visibility good and wind/tide unlikely to have been factors.
- 4.87. 27 Jun. Patrol conducted mooring and pontoon checks. Attempts to locate offending vessel at 4.86, above. Responded to a report of a tender adrift on the River at Bursledon. Located and returned to proper berth at a local marina.
- 4.88. 28 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with Hampshire Marine Police Unit. Having located the vessel at 4.86, contact details exchanged. Attended Hamble Jetty for an extended period, again with Hampshire Police to disperse a group of youths (14 yrs). RHHA officers faced significant abuse and threats of violence. Individuals known to Police, to whom the incident was reported. The Group was warned of its non-compliance with Bye Law 25 and the consequences. The group's response was abusive. This is the subject of an ongoing investigation into whether the evidence gathered may be sufficient to prosecute.
- 4.89. 29 Jun. Patrol conducted mooring and pontoon checks. Further liaison with Hampshire Marine Police Unit. Further swimmers dispersed from Hamble Jetty over an extended period in the morning, this time without difficulty. At 1830, in response to a further call from a member of the public at Hamble, patrol attended to disperse further anti-social swimmers. The offenders were the same as at 4.88. HM staff again faced verbal abuse and threats of physical violence from this group. The events of 28 and 29 July are subject to ongoing and joint investigatory effort with Hampshire Police.
- 4.90. 30 Jun. Patrol conducted mooring and pontoon checks. River Hamble Crabbing Competition held at the Harbour Office with 45 children entering and £332 being raised for Parkinsons' UK. Patrol once again attended Hamble Jetty in order to disperse a group of abusive swimmers, jumping from the Hamble bridge. Patrol rendered assistance to a mooring holder on the 'G' Run who had become foul on a mooring line. Patrol assisted a yacht with engine failure onto the mid-stream Visitor's Pontoon for defect rectification. Commercial tow of a yacht to the mid-stream Visitor's Pontoon. Tow of a further yacht with engine failure to a Marina for defect rectification. At 1217, Patrol responded to a report of a motor boat skipper, alongside in distress on the Warsash Fisherman's Jetty. Hampshire Ambulance attended. The casualty was discharged later that day, having received treatment for heat stroke.
- 4.91. 01 Jul. Patrol conducted mooring and pontoon checks. Commercial tow of a yacht from Warsash to a boatyard. Liaison with Hampshire Constabulary regarding anti-social and abusive behaviour at Hamble Jetty. Patrol responded to a report of a berthing collision near Swanwick under ongoing investigation. Patrol responded to a call from a member of the public reagring a small motor boat speeding in the Upper Hamble. On arrival, the motor boat in question admitted speeding and was escorted to the mouth of the River. Patrol responded to a call from a passing yacht reporting 'stranded cockle

- pickers' outside the RHHA jurisdiction on Hamble Spit. HMCG and Calshot Lifeboat involved. All made their way ashore. Southern IFCA informed.
- 4.92. 02 Jul. Patrol conducted mooring and pontoon checks. Swimmers witnessed in the water off Lands' End but well inshore. No issues reported. Patrol liaised with paddleboarders between Crableck and Swanwick to minimise impact on traffic using the Main Channel. Patrol stopped and gave verbal warnings to 3 PWC speeding at the mouth of the River. Patrol towed a vessel with engine failure from the entrance to the River to her proper berth.
- 4.93. 03 Jul. Patrol conducted mooring and pontoon checks. Patrol attended Hamble Jetty where 35 males and females were swimming from the Jetty. On this occasion, all dispersed without incident. Patrol assisted a motor launch with engine failure back to her berth at a sailing club. Patrol dissuaded 4 youths from climbing on a sailing club's pontoons.
- 4.94. 04 Jul. Patrol conducted mooring and pontoon checks. Patrol gave advice to a group of paddleboarders blocking the Main Channel off Universal Marina. Patrol towed a vessel out of fuel from RHCP to Swanwick. En route, patrol hailed and warned formally and in writing the skipper of a speeding dory. Routine liaison with Hamble Sea Scouts and Hamble Lifeboat.
- 4.95. 05 Jul. Patrol conducted mooring and pontoon checks. Patrol conducted litter collection along the shoreline at the RHCP. Patrol stopped and gave a formal written warning to a speeding RIB between the M27 and Rail Bridges. Patrol responded to a call from a commercial vessel regarding an individual swimmer, swimming with a marker float down River in the centre of the main channel. The individual, a male was uncompliant and directed ashore where he was warned of the dangers of swimming in such a manner. This is the subject of further ongoing investigation. Liaison with HMCG regarding a RIB aground on Hamble Spit with 3 persons on board. Patrol and Hamble Lifeboat attended. RIB anchored and 3 persons taken ashore. The vessel had run out of fuel.
- 4.96. 06 Jul. Patrol conducted mooring and pontoon checks. Monitoring of bait digging at Salterns'. Report made to SIFCA. Further deployment to Hamble Jetty to disperse swimmers. On this occasion, some had made their way to a sailing club and had removed a life belt from its stowage. These individuals were known to the RHHA, having been involved in previous incidents and were once again abusive. This incident has again been reported to the Police. The life belt was recovered by Patrol Officers and returned to the Club in question and the individuals reminded of its safety purpose.
- 4.97. 07 Jul. Patrol conducted mooring and pontoon checks. Monitoring of yachts departing on the RTI Race. Responded to a report of marine theft from a midstream mooring holder on the 'V' run. Assisted the owner in obtaining a crime number from the Police. Monitoring of a further 5 bait diggers near Salterns' boatyard. Patrol once again attended Hamble Jetty to disperse anti-social bathers.

4.98. 08 Jul. Patrol conducted mooring and pontoon checks. Patrol responded to further reports on anti-social bathers at Hamble Jetty. Dispersed.
