PART I

#### 1. PROPORTIONALITY AND APPOINTMENTS

1.1. This report concerns various matters relating to proportionality and appointments to committees and panels which require the approval of the County Council.

#### 2. **PROPORTIONALITY**

2.1. Part 1 of the Local Government and Housing Act 1989 requires the County Council to review the proportionality of its committees each year at its Annual Meeting. The proportionality between the political groups on the County Council is:

Conservative: 56
Liberal Democrat: 19
Labour: 2
Community Campaign for Hart: 1

2.2. In accordance with Standing Order 24.5 the County Council is asked to review the existing proportionality arrangements and make any changes as appropriate. The draft Proportionality Table is attached at Appendix 1 to this report.

#### 3. APPOINTMENTS

- 3.1. Standing Order 6.2 requires the County Council, at its Annual Meeting, to appoint a Chairman and Vice Chairman for every committee and standing advisory panel of the County Council until the next Annual Meeting. All Chairmen and Vice-Chairman of Committees must be elected Members of the County Council. The nominations are attached as Appendix 2 to this report.
- 3.2. Standing Order 26 requires the County Council, at its Annual Meeting, to appoint its full quota of eight members to the Hampshire Fire and Rescue Authority. The nominations are as follows:

Councillor Chris Carter, Councillor Roz Chadd, Councillor Liz Fairhurst, Councillor Jonathan Glen, Councillor Geoff Hockley, Councillor Roger Price, Councillor David Simpson, Councillor Rhydian Vaughan.

- d) That Councillor Peter Edgar be appointed as a full Member of the Children and Families Advisory Panel to fill a vacancy created by Councillor Pal Hayre taking over as Vice-Chairman of the Panel from Councillor Roz Chadd.
- e) That Councillor Fran Carpenter replace Councillor Roz Chadd as a full Member of the Education Advisory Panel and Councillor Peter Edgar replace Councillor Steve Forster as a Conservative Substitute Member on the Panel.
- f) That Councillor Jan Warwick fills a vacancy on the Regulatory Committee created by Councillor Lance Quantrill taking over as Vice-Chairman of the Committee from Councillor Judith Grajewski.
- g) That Councillor Wayne Irish replace Councillor David Simpson on the Regulatory Committee and that Councillor David Simpson be appointed as the second Liberal Democrat Substitute Member.
- h) That Councillor Judith Grajewski be appointed to the Health and Wellbeing Board for Hampshire and to report an appointment made under delegated authority by the County Council's Monitoring Officer in consultation with the Chairman of the Board of Maggie MacIsaac as South Eastern Hampshire Clinical Commissioning Group's Substitute Representative on the Board.
- i) That Councillor Roz Chadd be appointed as a Conservative Substitute Member on the Standing Advisory Committee for Religious Education to fill a vacancy created by Councillor Roy Perry becoming Chairman of the Advisory Committee.
- j) That Councillor Dominic Hiscock replace Councillor Jackie Porter as the second Liberal Democrat Substitute Member on the Buildings, Land and Procurement Panel.
- k) That Councillor Tonia Craig replace Councillor Jackie Porter as the Liberal Democrat Substitute Member on the Corporate Parenting Board.
- That Councillor Dominic Hiscock replace Councillor Jackie Porter as the Liberal Democrat Substitute Member on the Employment in Hampshire County Council (EHCC) Committee.

- m) That Councillor Jan Warwick and Councillor Peter Latham (deputy) be reappointed as the County Council's representatives on the Hampshire Police and Crime Panel.
- n) That Councillor Stephen Reid replace Councillor Mel Kendal as one of the County Council's representatives on the County Councils Network and on the Local Government Association General Assembly.
- That Councillor Keith Mans be appointed as the County Council's representative on South East Strategic Leaders (SESL) and that Councillor Roy Perry be appointed as the Deputy Member.
- p) That Councillor Keith Mans be appointed as the County Council's representative on South East 7 Board (SE7) and that Councillor Roy Perry be appointed as the Deputy Member.
- q) That Captain Phil Buckley replace Captain Martin Phipps as the co-opted member representative for Associated British Ports on the River Hamble Harbour Management Committee.
