Addendum to Agenda Item 7 of the Meeting of the River Hamble Harbour Board on Friday 12 July 2019

- 69. 5 Jun. Patrol conducted mooring and pontoon checks. Installation of new tide gauges. Recovered a large log from the Main Channel between the M27 Bridge and the Rail Bridge.
- 70. 6 Jun. Patrol conducted mooring and pontoon checks. Commercial tow of a mid-stream moored yacht. Routine patrol boat maintenance.
- 71. 7 Jun. Patrol conducted mooring and pontoon checks. Replacement of No 4 Navigation Light. Commercial tow of a mid-stream moored yacht. Attended and towed a vessel with propulsion failure in the Mouth of the River to the Harbour Master's Jetty Warsash for defect rectification
- 72. 8 Jun. Patrol conducted mooring and pontoon checks.
- 73. 9 Jun. Patrol conducted mooring and pontoon checks. Patrol and a local boat maintenance company attended a motor vessel aground on Hamble Spit. Towed free. Skipper had attempted to cross the bar between 6 and 8 buoys without having checked the depth. Skipper re-briefed regarding the requirement to plan his navigation responsibly.
- 74. 10 Jun. Patrol conducted mooring and pontoon checks. Removed and locked a non-paying vessel from the Harbour Master's Jetty Warsash. Gave assistance to a visiting yacht at Hamble Jetty. Moved four swimmers from Hamble Jetty compliant. Stopped and warned a motor vessel off Crableck for excessive speed and wash. Found and returned to owner an abandoned paddle. Responded to a call from a member of the public regarding a swan with a fishing line and float caught in its bill. Swan located but unable to reach it. To be followed up.
- 75. 11 Jun. Patrol conducted mooring and pontoon checks. Followed up on incident with a mute swan traced to mate and nest North of the Rail Bridge. Again, unable to reach. Liaison with RSPB.
- 76. 12 Jun. Patrol conducted mooring and pontoon checks. Further search for swan – not found. Attended a private yacht aground on Hook Spit owing to skipper navigational error. Hamble Life Boat in attendance. Yacht re-floated. Support to a visiting yacht carrying out rigging maintenance. Took a report that the swan had been caught and the fishing line and float removed by two members of the public. Routine First Aid checks.
- 77. 13 Jun. Patrol conducted mooring and pontoon checks. Escorted a large tow from Crableck to Hamble. Witnessed a small sailing vessel aground on Hamble Spit. Attended and pulled clear. Skipper error in medium to strong winds. Boat coding work. Patrol gave assistance to the skipper of a mid-stream moored yacht on the 'L' run, unable to disembark because of a dislocated hip sustained while under sail. Following medical advice, transferred the sailor and his wife to a Marina where they transferred via own vehicle to hospital.

- 78. 14 Jun. Patrol conducted mooring and pontoon checks. Attended a vessel which had misjudged her approach to the Harbour Master's Jetty at Warsash and made contact with the downstream navigation light post. No damage sustained. Liaison with a sailing club regarding damage sustained by a vessel by poor fendering in stronger winds. Assistance give to a small motor boat aground at Swanwick. Towed clear. Slipway clearance work. Routine patrol boat maintenance.
- 79. 15 Jun. Patrol conducted mooring and pontoon checks. Assistance given to a visiting yacht with propulsion failure off Crableck. Responded to a report from River user of a dinghy, capsized and in difficulty in the mouth of the River in strong winds. Patrol attended. Two very young children had been recovered by an attending boat and two adults were now onboard and dropping the mainsail for recovery to the attached sailing club. First Aid given (technical blankets). Party escorted back to the sailing club. Details taken. Towed a mid-stream moored yacht to her proper mooring. Patrol stopped and warned a motor vessel with excessive speed and wash.
- 80. 16 Jun. Patrol conducted mooring and pontoon checks. Assistance given to a mooring holder regarding theft from his vessel. Patrol took a report from a River User regarding a minor berthing collision with a moored yacht owing to skipper error. Details exchanged. Slipway clearance at Warsash.
- 81. 17 Jun. Patrol conducted mooring and pontoon checks. All week: work experience given to a school leaver. Assisted a single-handed sailor in mooring his yacht. Routine liaison with Hamble Life Boat. Recovered a young Oyster Catcher to a pontoon and her parent. Hosted a visit from a group of local Sea Scouts.
- 82. 18 Jun. Patrol conducted mooring and pontoon checks. Liaison with Hampshire County Council regarding the condition of the Harbour Wall adjacent to the path to the Harbour Office. Boat coding wok. Recovered two large logs from the Upper Hamble.
- 83. 19 Jun. Patrol conducted mooring and pontoon checks. Patrol gave assistance to a yacht with propulsion failure in the mouth of the River pending arrival of a maintenance company. Recovered a large log from the Main Channel off Crableck. Returned a recovered tender to her owner.
- 84. 20 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with Hampshire Marine Police Unit. Observed and took pictures of spalling concrete on the A27 Road Bridge for transmission to Hampshire Highways. Advised a visiting sailing school yacht on the requirement to maintain a listening watch on VHF Ch 68 while within the River. Boat coding work.
- 85. 21 Jun. Patrol conducted mooring and pontoon checks. Liaison with UK Border Force. Assemble competition entry for Warsash Scarecrow Competition. Liaison with the Crown Estate mooring contractor.
- 86. 22 Jun. Patrol conducted mooring and pontoon checks. Support to a dinghy regatta. Gave direction to a private fisherman to untie from an Aid to

Navigation. Verbal warnings given to a number of speeding motor vessels. Routine liaison with Hamble Life Boat.

- 87. 23 Jun. Patrol conducted mooring and pontoon checks. Gave assistance to two small motor vessels with propulsion failure.
- 88. 24 Jun. Patrol conducted mooring and pontoon checks. Attended vicinity of a fuel berth where a light sheen of oil had been reported. On arrival, no obvious source and jetty clean. Remaining light sheen broke up with prop wash. Routine patrol boat maintenance. Boat coding work.
- 89. 25 Jun. Patrol conducted mooring and pontoon checks. Routine liaison with a sail training company about visitors' payments.
- 90. 26 Jun. Patrol conducted mooring and pontoon checks. Liaison with ABP Southampton regarding the owner of a yacht, apparently from Hamble, engaged in a close-quarters situation with a commercial vessl in Southampton Water. Liaison with a marina regarding a vessel reported as having created excessive wash.
- 91. 27 Jun. Patrol conducted mooring and pontoon checks. Oil spill response training for on water and office staff. Liaison with a member of the public regarding a set of lost keys. Recovered a tender adrift in the centre of the Main Channel off Warsash. Returned to its owner.
- 92. 28 Jun. Patrol conducted mooring and pontoon checks. To RHCP Jetty to assess modification for general benefit. Preparations for Round the island Race. Movement of vessels to accommodate visiting commercial pleasure craft. Attended and observed swimming at RHCP jetty. Gave assistance to a small motor vessel with propulsion difficulties off Swanwick. Responded to a call from a member of the public regarding a speeding RIB in the Upper Hamble. Attended but not located.
- 93. 29 Jun. Patrol conducted mooring and pontoon checks. Round the Island Race. Busy traffic. Three patrol craft deployed. Commercial tow of a vessel from the mid-stream VP to Warsash Jetty. Attended Hamble Jetty and asked a group of young girls to vacate a moored tender, not theirs. Compliant. Report of 4 vessels speeding between the Upper Hamble and Crableck. Patrol attended. Formal written warning given to the owner of a RIB from Sholing. Owner had clearly been drinking but was not deemed drunk. Further verbal warning given to the master of a RIB creating excessive wash off Warsash. Liaison with River Users as witnesses to speeding events.
- 94. 30 Jun. Patrol conducted mooring and pontoon checks. Presence between Crableck and Bursledon to deter and bear down on speeding. Towed a vessel with propulsion failure from the mouth of the River to Warsash for defect rectification. Warned a PWC driver about the creation of excessive wash off Swanwick. Lost property work.

- 95. 01 Jul. Patrol conducted mooring and pontoon checks. HM, DHM and Moorings Officer to Cowes to witness new Harbour Management System in operation.
- 96. 02 Jul. Patrol conducted mooring and pontoon checks. Exchanged the navigation light on No 4 pile. Stopped and warned a speeding PWC off Warsash. Reports made to Southern IFCA and UK Border Force regarding a large number of cockle pickers om Hamble Spit.
- 97. 04 Jul. Patrol conducted mooring and pontoon checks. Routine maintenance of Aids to Navigation. Liaison with HM Coast Guard stood by a vessel under tow on the way into the River for defect rectification at the Harbour Master's Jetty Warsash. Liaison with UK Border Force. Attended Hamble Jetty to disperse swimmers. Bailed out a tender, inundated by swimmers.
- 98. 05 Jul. Patrol conducted mooring and pontoon checks. Re-briefed the skipper of a RIB creating excessive wash. Engagement with the owner of a vessel moored near the River Hamble Country Park Jetty regarding anti-social behaviour of swimmers, climbing onto boats.
- 99. 06 Jul. Patrol conducted mooring and pontoon checks. Warsash Festival. Awarded First Prize in scarecrow competition for the 'Scare Crab'. Attendance at Hamble Jetty to disperse youths. Liaison with Hampshire Police regarding youths jumping into the River from the A27 Bridge. While on patrol in the Upper Hamble, stopped and warned a small RIB creating excessive wash. Attended Hamble Spit following a call from a member of the public reporting two persons stranded. On arrival two kayak owners had disembarked. Safe. Liaison with HM Coast Guard and Hamble Life Boat regarding a person requiring medical assistance. Once again, Solent Coastguard diverted the vessel to a location other than Warsash to meet First Responders. Subject of ongoing work.
- 100. 07 Jul. Patrol conducted mooring and pontoon checks. Liaison with two River Users regarding an ill-tempered exchange arising from a lack of understanding of the IRPCS.
- 101. 08 Jul. Patrol conducted mooring and pontoon checks. Routine liaison with the Crown Estate mooring contractor. Liaison with a marina to give advice on the correct disposal of time-expired marine pyrotechnics. Tide gauge maintenance. Dispersal of swimmers at Hamble Jetty and liaison with Hampshire Marine Police Unit.
