1. Executive Summary

1.1. The purpose of this paper is to provide the Pension Fund Panel and Board with the Chief Internal Auditor's opinion on the adequacy and effectiveness of Pension Services' framework of risk management, internal control and governance for the year ending 31 March 2017.

2. Chief Internal Auditors Annual Report and Opinion

2.1. In accordance with 'proper practices' as defined in the Public Sector Internal Audit Standards (updated 2016), the Chief Internal Auditor is required to provide a written report reviewing the effectiveness of the system of internal control.

2.2. The Annual Report for 2016/17 (attached at Appendix 1) provides the Chief Internal Auditor's opinion on the system of risk management, internal control and governance for the year ending 31 March 2017.

2.3. The Pension Fund Panel's attention is drawn to the following points:

- Internal audit was compliant with the Public Sector Internal Audit Standards during 2016/17;
- The revised internal audit plan for 2016/17 has been delivered;
- 'Substantial Assurance' can be placed on the County Council's (Pension Services') framework of governance, risk management and management control and audit testing has demonstrated controls to be working in practice; and

- Where internal audit work identified areas where management controls could be improved or where systems and laid down procedures were not fully followed, appropriate corrective actions and a timescale for improvement were agreed with the responsible managers.

3. Recommendation

- 3.1. That the Pension Fund Panel and Board accepts the Chief Internal Auditor's annual report and opinion statement for 2016/17.
