


Fall and rise of GDP







Impact on labour market (1)




Jobs postings in HIOW





Impact on labour market (2)




Unemployment: claimant count, HIOW




Winter Economy Plan

- New Job Support Scheme
- Self employed income support extended to end April 2021
- VAT cut for hospitality/tourism extended end of March 2021
- Business loans payback extended from 6 to 10 years
