### 1. The decision:

1.1. That authority be given for the County Council to dedicate a public bridleway 4 metres in width over land within its ownership, running between Kings Worthy Bridleway 501 and Woodhams Farm.

# 2. Reason(s) for the decision:

- 2.1. In 2020 authority was given for the County Council to dedicate a public bridleway between the points outlined in paragraph 1.1. Part of the route to be dedicated as bridleway was previously dedicated as a public footpath in 2002 (Kings Worthy Footpath 502).
- 2.2. The 2020 decision record specified that the width of the dedicated route was to be 3 metres in width. However, upon completion of the deed it was realised that Footpath 502 had an existing width of 4 metres, meaning that the newly dedicated bridleway was narrower than the pre-existing right of way. In order to address this anomaly it is therefore proposed that a new deed of dedication is prepared which will create bridleway rights extending to 4 metres in width, thus coinciding with the extent of the existing footpath.
